RENTAL AGREEMENT

The members and community surrounding LMVFD are proud of their department and welcome you to our wonderful facility. We take pride in maintaining a miraculous facility while also providing you the opportunity to enjoy some of its great benefits outside of saving lives and protecting property. We do our best to ensure that this department remains clean and healthy and that all devices are in excellent working condition at all times and it is our full expectation of renters to do the same. Therefore, the undersigned party agrees to pay LMVFD a \$100.00 security deposit two weeks prior to the rental date that will be refunded pending an inspection from a member of LMVFD for cleanliness and organization of the "as is" of the fire department upon entry of the rental agreement. The undersigned also agrees to pay, in full, the amount designated above in the rental options at least two days prior to the event. As this is a non-profit organization that depends solely on donations and local funding we ask that the renter utilize their own cleaning supplies to clean up any items that may have been used during the rental agreement. This may include, but is not limited to, dishes, cups, serving trays or bowls, trashcans (emptied and a new bag replaced), meeting room vacuumed (if used), pavilion trash picked up and dumped (if used), bathrooms cleaned (we will replace the paper), kitchen appliances and countertops cleaned and hallway, kitchen, bathroom and bay floors mopped (if used) and everything returned to its original location. The undersigned understands that if the department is not left in the condition it was when rented that the security deposit WILL NOT be refunded.
